>> LISA: ALL RIGHT. GOOD MORNING, EVERYONE. GOOD MORNING, EVERYBODY IF YOU HAVE A T-COIL, JUST REMEMBER TO TURN THAT ON. THIS ROOM IS LOOPED. CAN EVERYONE HEAR ME OKAY?

ALL RIGHT.

IT IS GREAT TO SEE SO MANY PEOPLE HERE. THANK YOU ALL FOR COMING. MY NAME IS LISA. I'M THE PRESIDENT OF THIS CHAPTER. THIS IS THE LOS ANGELES CHAPTER OF HLAA. THE HEARING LOSS ASSOCIATION OF AMERICA.

I SHOULD ACTUALLY SAY I'M THE SOON-TO-BE-NOT PRESIDENT. WE ARE HAVING OUR STEERING COMMITTEE ELECTIONS TODAY. AFTER TODAY'S MEETING THE STEERING COMMITTEE, THE NEW MEMBERS OF THE STEERING COMMITTEE AND THE CURRENT MEMBERS WILL MEET AND WILL BE ELECTING NEW OFFICERS.

SO THERE'LL BE A NEW PRESIDENT AFTER TODAY.

WE HAVE A TON OF STUFF GOING ON TODAY. BASICALLY AGENDA WE NEED TO VOTE ON BYLAWS, WHICH I KNOW YOU'RE ALL REALLY EXCITED ABOUT. (CHUCKLES).

I POSTED THE BYLAWS TO THE YAHOO GROUP AND I'M SURE ALL OF YOU READ THEM THOROUGHLY.

OKAY. SO WE ARE GOING TO DO THAT FIRST. THEN WE ARE GOING TO HAVE OUR ELECTIONS. WE'LL TAKE A BREAK, ABOUT MID-WAY THROUGH. WE ARE GOING TO COME BACK HERE AND WE WANT TO SPEND A FEW MINUTES REMEMBERING A DEAR MEMBER OF OUR CHAPTER THAT WE LOST LAST MONTH. AL KLINK.

AND WE ARE ALSO GOING TO MEET, NOT SURE IF SHE IS HERE YET, THE NEW HOH SPECIALIST AT G.L.A.D. AND WE HAVE MORE CHAPTER BUSINESS TO TAKE CARE OF.

SO THERE'S A LOT GOING ON. AND I SEE A LOT OF NEW FACES.

AND BECAUSE WE HAVE A LOT OF NEW PEOPLE HERE, JUST A REMINDER, THIS FACILITY IS THE HEAR CENTER. IT IS A NONPROFIT ORGANIZATION. THEY OFFER AUDIOLOGY AND HEARING AID SERVICES, SPEECH THERAPY AT REDUCED RATES. WE'VE BEEN MEETING HERE SINCE THE CHAPTER STARTED 11 YEARS AGO. SO WE ARE BASICALLY BORROWING THIS SPACE. SO WE ASK THAT YOU RESPECTFUL, PLEASE DO NOT GO IN ANY OF OFFICE AREAS. JUST STAY IN THIS ROOM, FOOD AREA AND BATHROOMS.

AND ALSO, ALAN SIMON IS THE DIRECTOR OF THE -- ELLEN -- SHE ASKED ME TO SHARE, THEY ARE ACTUALLY HAVING SEVERAL EVENTS COMING UP AND WE WANTED YOU TO BE AWARE OF THEM. EVERYONE IS WELCOME TO COME.

SATURDAY OCTOBER 10 AND SATURDAY OCTOBER 17 -- I'LL PASS THESE OUT -- THEY ARE HAVING AN OPEN HOUSE HERE. FREE HEARING SCREENINGS, FREE HEARING AID CLEANINGS, FREE T-COIL CHECKS ON A FIRST-COME, FIRST-SERVE BASIS.

THEN ON TUESDAY OCTOBER 19, FROM 10 TO 12, IF YOU WORK YOU PROBABLY CAN'T MAKE THIS. "YOUR BRAIN AND HEARING, USE IT OR LOSE IT." AND WE'VE ALL HEARD ALL OF RESEARCH IN THE RECENT YEARS ABOUT HEARING LOSS BEING ASSOCIATED WITH COGNITIVE -- DID YOU HAVE A QUESTION?

- >> MONDAY THE 19? OR TUESDAY THE 20?
- >> LISA: I'LL FIND OUT. I DON'T KNOW.

AND I'LL POST IT ON THE YAHOO GROUP. ARE YOU ON YAHOO GROUP? I CAN E-MAIL YOU TOO.

IT IS ABOUT USING OR LOSING YOUR BRAIN POWER. AND HOW THAT'S ASSOCIATED WITH HEARING LOSS.

AND FINALLY, THEY ARE HAVING A FALL FESTIVAL. AND I THINK THIS IS A FUNDRAISER FOR THIS ORGANIZATION. IT IS \$35. IT LOOKS LIKE A FAIR. FOOD PONY RIDES, BALLOON ARTISTS, BOUNCE HOUSE AND COMMUNITY INFORMATION AND MORE.

SO AGAIN, I'LL PASS OUT THESE FLYERS. ALL FOR THE HEAR CENTER.

ANOTHER THING BEFORE WE GET STARTED, WE HAVE ANOTHER GUEST HERE, RICHARD? YOU WANT TO RAISE YOUR HAND?

- >> RICHARD: GOOD MORNING.
- >> LISA: HE'S ASKING FOR SOME HELP. HE HAS DEVELOPED -- AND I THINK HE HAS

FLIERS. HE HAS DEVELOPED A DEVICE, HE WANTS PEOPLE WITH HEARING LOSS TO GIVE HIM HONEST FEEDBACK. HE IS DEVELOPING IT RIGHT NOW. SO AT BREAK OR AFTER THE MEETING, IF YOU WANT TO HELP HIM OUT AND JUST TEST OUT HIS DEVICE. SHOULD ONLY TAKE A FEW MINUTES. WE DON'T HAVE TIME DURING THE MEETING. BUT I TOLD HIM AT THE BREAK AND AFTER THE MEETING HE CAN GET PEOPLE'S FEEDBACK.

JUST REALLY I THINK YOU WANT HONEST FEEDBACK ON HOW THIS WORKS.

SO, WE ARE JUST GOING TO JUMP RIGHT INTO THIS. WE HAVE MELODIE TODAY CAPTIONING. SHE DOESN'T KNOW EVERYBODY'S NAMES. SO IF YOU SPEAK (HOOTS) -- AND I ACTUALLY DON'T KNOW SEVERAL PEOPLE'S NAMES HERE AS WELL. SO IF YOU SHARE ANYTHING, CAN YOU PLEASE SAY YOUR NAME SO THAT WILL HELP MELODIE OUT BEFORE YOU START TALKING.

ALL RIGHT.

THE FIRST THING THAT WE HAVE TO DO IS WE NEED TO VOTE ON OUR BYLAWS CHANGES. WHENEVER WE MAKE CHANGES TO THE BYLAWS, WE NEED TO, THE STEERING COMMITTEE NEEDS TO VOTE ON IT AND THE CHAPTER NEEDS TO VOTE ON IT. SO THAT'S WHY WE ARE DOING THAT TODAY.

THE CHANGES THAT WE HAVE PROPOSED ARE BASICALLY TO GIVE THE STEERING COMMITTEE MORE FLEXIBILITY IN REGARDS TO THE NUMBER OF MEMBERS ON THE STEERING COMMITTEE.

SO, I PUT CHANGES UP HERE (ON SCREEN). . . ON THIS SLIDE.

BASICALLY IN THE TOP IS WHAT WE HAVE CURRENTLY. AND THE PROPOSED REVISION IS IN RED.

RIGHT NOW WE HAVE NINE STEERING COMMITTEE MEMBERS. WHAT OUR PROPOSED REVISION IS THAT THE STEERING COMMITTEE WILL BE MADE UP OF A MINIMUM OF THREE MINIMUMS, BUT NO MORN NINE MEMBERS. THIS IS TAKEN STRAIGHT FROM NATIONAL'S TEMPLATE. WE THOUGHT THAT WAS A GOOD SOLUTION TO HANDLING, HAVING MORE FLEXIBILITY IN YEARS TO COME. SO WE ARE NOT STUCK TO ONE NUMBER OF MEMBERS FOR THE STEERING COMMITTEE.

ALL OF THE OTHER CHANGES HAVE TO DO WITH THIS CHANGE. SO, -- HOW DO I DO THIS?

I'M KIND OF STUCK HERE.

SORRY.

OKAY.

OKAY. THE SECOND CHANGE AGAIN IS TAKEN FROM NATIONAL'S TEMPLATE. CURRENTLY WE OUR BYLAWS SAY THAT WE HAVE FOUR OFFICERS. THAT WOULD BE THE PRESIDENT, VICE PRESIDENT, TREASURER, AND SECRETARY.

THE PROPOSED CHANGE IS THAT WE HAVE THREE OFFICERS REQUIRED. THAT'S THE PRESIDENT, TREASURER AND SECRETARY. AND THE STEERING COMMITTEE CAN CHOOSE TO ALSO ELECT A VICE PRESIDENT.

AND FINALLY THE LAST CHANGE CURRENTLY WE HAVE VOTING REQUIREMENTS. THE STEERING COMMITTEE WILL HAVE A QUORUM OF FIVE MEMBERS, WHICH OBVIOUSLY DOESN'T MAKE SENSE. YOU KNOW, WE HAVE FEWER MEMBERS ON THE STEERING COMMITTEE. AND THE CHAPTER MEMBERSHIP QUORUM WILL BE 50% PLUS ONE OF VOTING MEMBERS IN ADDITION TO THREE STEERING COMMITTEE MEMBERS.

PROPOSED CHANGE IS THE STEERING COMMITTEE WILL HAVE A QUORUM OF A MAJORITY OF STEERING COMMITTEE MEMBERS NOT LESS THAN TWO, INCLOUDING THE PRESIDENT. IN THE CASE OF A TIED VOTE, IF WE HAVE AN EVEN NUMBER OF MEMBERS ON THE STEERING COMMITTEE AND WE HAVE A TIED VOTE, THE PRESIDENT'S VOTE WILL COUNT TWICE.

AND THE CHAPTER MEMBERSHIP QUORUM WILL BE AT LEAST TEN MEMBERS, WHICH CAN INCLUDE STEERING COMMITTEE MEMBERS.

SO I'M GOING TO MAKE A MOTION THAT WE UPDATE THE BYLAWS TO REFLECT THESE CHANGES. AND THEN WE CAN OPEN IT UP TO DISCUSSION. OKAY? IF YOU HAVE ANY QUESTIONS OR COMMENTS.

SO I'M GOING TO MAKE A MOTION THAT WE UPDATE THE BYLAWS TO INCLUDE THE CHANGES I'VE JUST GONE OVER WITH YOU.

CAN I GET A SECOND?

- >> ALICIA: I SECOND.
- >> LISA: QUESTIONS? COMMENTS?
- >> DIANE: I'M SORT OF CONFUSED ABOUT THE TERM "CHAPTER MEMBERSHIP QUORUM" IS THAT VOTING ON THE STEERING COMMITTEE, OR VOTING OVERALL?
  - >> LISA: IS THIS ON? MAYBE IT WILL HELP IF IT TURNED IT ON.

DOES THAT WORK?

OKAY

THAT'S A CHAPTER MEMBERSHIP. AND THE VOTING MEMBERS ARE PEOPLE WHO ARE PAID MEMBERS OF NATIONAL. SO, TODAY WHEN WE VOTE, ONLY MEMBERS OF NATIONAL CAN VOTE. DOES THAT MAKE SENSE? AND THERE NEEDS TO BE AT LEAST TEN MEMBERS VOTING. ANY OTHER QUESTIONS OR COMMENTS BEFORE WE VOTE TO MAKE THESE CHANGES? OKAY.

SO, I GUESS AGAIN, WE ARE JUST GOING TO DO THIS, WE DON'T NEED WRITTEN PROOF. SO WHOEVER IS A NATIONAL MEMBER, A PAID MEMBER OF NATIONAL, YOU CAN VOTE. ALL IN FAVOR OF CHANGING OUR BYLAWS CAN YOU PLEASE RAISE YOUR HANDS?

AND ALL RIGHT, ALL NOT IN FAVOR? ANY OBJECT? ALL RIGHT.

WE CAN --

[APPLAUSE]....

- >> KEN: DID WE RECORD THAT?
- >> LISA: KATHERINE WILL WRITE IT DOWN. SHE'S OUR SECRETARY FOR ANOTHER COUPLE OF HOURS.

[GIGGLES].

ALSO WILL HAVE TRANSCRIPTS OF THE MEETING.

THAT'S ONE THING WE CAN CHECK OFF MY LIST.

THE NEXT THING WE NEED TO GET TO IS OUR STEERING COMMITTEE ELECTIONS. I WANT TO TURN THIS OFF.

ALL RIGHT.

OKAY. THIS IS THE SITUATION:

WE CURRENTLY HAVE NINE MEMBERS ON OUR STEERING COMMITTEE. WE ARE LOSING SEVERAL OF THOSE MEMBERS. I DON'T KNOW IF MOST OF YOU KNOW, BUT RAM, WE ELECTED RAM LAST YEAR TO THE STEERING COMMITTEE. HE JUST MOVED TO DENVER A COUPLE OF MONTHS AGO. SO HE IS NO LONGER HERE.

THEN WE HAVE STEPHANIE, KAT, DANNY WHO IS NOT HERE AND GEORGIA ARE ALL STEPPING DOWNFUL THEY WOEPT BE RUNNING AGAIN.

WE HAVE PAT, KEN, AND ALICIA, WHO WERE ELECTED LAST YEAR. AND THEY ARE GOING TO STAY ON THE STEERING COMMITTEE. THEY STILL HAVE ONE YEAR.

AND THEN I'M ACTUALLY UP FOR RE-ELECTION TODAY. MY TERM ENDS TODAY.

SO THREE SEATS FILLED RIGHT NOW. THAT MEANS EVEN THOUGH WE JUST VOTED ON WE HAVE A MINIMUM OF THREE TO MAXIMUM OF NINE MEMBERS, WE ARE SHOOTING FOR SEVEN MEMBERS TODAY.

SO THAT MEANS WE HAVE FOUR OPEN SEATS. AGAIN, THE REQUIREMENTS FOR BEING ON THE STEERING COMMITTEE, YOU HAVE TO BE A MEMBER OF NATIONAL. IF YOU AREN'T A MEMBER OF NATIONAL, AND YOU REALLY WANT TO RUN TODAY, WHICH WE'RE HOPING, YOU CAN JOIN NATIONAL. IT IS NOT A BIG DEAL RIGHT NOW.

YOU HAVE TO BE ABLE TO COMMUNICATE BY E-MAIL. WE DO ALL OUR COMMUNICATION BY E-MAIL IN BETWEEN THE MEETINGS.

AND THEN YOU HAVE TO BE ABLE TO ATTEND MOST OF THE CHAPTER MEETINGS AND THE STEERING COMMITTEE MEETING.

THE STEERING COMMITTEE MEETS PRETTY MUCH EVERY OTHER MONTH AND USUALLY AFTER THE CHAPTER MEETINGS.

ANY QUESTIONS?

- >> WENDY. ACTUALLY I HAVE A QUESTION THAT RELATES TO THE STEERING COMMITTEE SIZE AGAIN. I'M SORRY. CAN I ASK IT NOW?
  - >> LISA: WE JUST VOTED ON IT. BUT YOU CAN ASK. THIS IS WENDI, BY THE WAY.
  - >> WENDI: MELODIE, I'M WENDI.

THE SEVEN THAT WE ARE SHOOTING FOR, IS THAT GOING TO BE THE NORM OR -- EVEN THOUGH WE REDUCED IT TO NINE, IS IT OUR GOAL TO ALWAYS TRY TO MAINTAIN SEVEN? AND HOW DO WE DETERMINE WHETHER THIS YEAR OR WE AND WANT FOUR OR NEXT YEAR FIVE

OR SEVEN OR SIX? HOW IS THAT GOING TO WORK IN TERMS OF --

>> LISA: I THINK THAT'S SOMETHING THAT THE NEW STEERING COMMITTEE ARE GOING TO DISCUSS.

THE CURRENT STEERING COMMITTEE FELT THAT SEVEN WAS A GOOD NUMBER. BUT WE WANTED TO HAVE FLEXIBILITY SO THAT WE DON'T HAVE TO KEEP CHANGING THE BYLAWS. WE DON'T REALLY KNOW -- I THINK AFTER 11 YEARS, WE'VE BEEN DOING GREAT AS A CHAPTER. BUT WE HAVEN'T MADE A LOT OF CHANGES OVER THE YEARS.

AND I THINK ALL OF US SORT OF FEEL THAT WE NEED TO FIGURE OUT WHAT OUR GOALS ARE. AND FIGURE OUT OUR DIRECTION.

WE COULD JUST KEEP GOING THE WAY WE ARE GOING. BUT WE THINK THAT IT MIGHT BE TIME TO MAKE SOME CHANGES.

AND SO, GIVEN THAT, I THINK THERE'S BEEN SOME DISCUSSION OF MAYBE HAVING A SMALLER STEERING COMMITTEE AND HAVING COMMITTEES, PEOPLE THAT THEY DON'T HAVE TO BE ON STEERING COMMITTEE. WE HAVE COMMITTEES, PEOPLE VOLUNTEERING TO DO THINGS THAT AREN'T ON THE STEERING COMMITTEE.

SO, IS THAT PRETTY MUCH HOW THE REST OF STEERING COMMITTEE FEELS? >> OKAY.

>> LISA: ALL RIGHT. WE ARE JUST GOING TO START WITH THESE ELECTIONS.

IS ANYONE INTERESTED IN RUNNING? ANYONE WANT TO NOMINATE THEMSELVES OR NOMINATE SOMEONE ELSE? AND THIS IS FOR A TWO-YEAR TERM ON STEERING COMMITTEE. ANYONE? [GIGGLES].

- >> KEN: I WOULD LIKE TO NOMINATE JUDY HOEWISCH.
- >> LISA: DO YOU ACCEPT NOMINATION?
- >> DRUM ROLL.

YES. I DO.

- >> LISA: GREAT. ANYBODY ELSE?
- >> MITZI: SINCE LISA IS UP FOR RE-ELECTION, I NOMINATE LISA YUAN.
- >> WENDI: I WAS GOING TO DO THAT. WENDI.
- >> LISA: I ACCEPT NOMINATION.
- >> PAT: HOP TO IT.

GOOD THING YOU ARE NOT UP FOR --

I NOMINATE TIM.

- >> LISA: TIM DO YOU ACCEPT THE NOMINATION?
- >> TIM: THAT'S A LONG WALK FOR YOU. YES, I DO.
- >> LISA. YAY. SO WE HAVE THREE PEOPLE.

(APPLAUSE)

ANYONE ELSE?

DIANE?

- >> DIANE: DO THE PEOPLE WHO ARE CURRENTLY ON THE STEERING COMMITTEE BUT ARE UP FOR RE-ELECTION, DO THEY HAVE TO BE RE-NOMINATED?
- >> LISA: I'M THE ONLY ONE RUNNING AGAIN. THE OTHER PEOPLE ARE ALL STEPPING DOWN. THEY DECIDED NOT TO RUN AGAIN.
- $\,>>$  DIANE. AND THEN THOSE WHOSE TERMS ARE NOT YET UP. I'M NOT AWAKE EITHER, KEN.

>> LISA: OKAY. ANYONE ELSE?

ALL RIGHT. I THINK THE BYLAWS STATE THAT WE NEED TO VOTE EVEN IF WE DON'T HAVE THE AMOUNT OF MEMBERS WITH OPEN SEATS. I DON'T EVEN KNOW HOW TO SAY THIS. - -- ALL OF THE VENUES THAT YOU'VE GOTTEN TO CAPTION THEIR LIVE PERFORMANCES. AND PEOPLE HEAR ABOUT WORK AND THEY THINK THE LA CHAPTER IS ON TOP OF THINGS. AND IT'S BEEN MAINLY YOU. AGAIN, I WANT TO THANK YOU, I'VE BEEN SO

IMPRESSED WITH ALL OF THE ACCOMPLISHMENTS.

I DON'T KNOW IF MOST OF YOU KNOW, BUT GEORGIA IS STAYING ON AS ADVOCACY CHAIR. WE ARE REALLY HAPPY ABOUT THAT.

>> LISA: WE HAD RAM TAKE OVER LAST YEAR FOR THE GARAGE SALE. I'M GOING TO PUT THIS OUT NOW. THAT WE WILL BE LOOKING FOR A GARAGE SALE HOST NEXT APRIL -- OH -- YES. OKAY.

>> JOE: I DON'T HAVE A MICROPHONE.

AND I HATED HAVING HEARING LOSS. I HATED BEING A PERSON WITH HEARING LOSS. SO TO THINK ABOUT THAT PERSON AND THAT NOW I'M REPRESENTING AN ORGANIZATION THAT IS ALL ABOUT HEARING LOSS, AND I'VE JUST COME TO ACCEPT IT AND ACCEPT MYSELF, I CAN'T THINK OF A BETTER GIFT THAN THAT.

JOINING KEN, ALICIA AND PAT. THANK YOU TO THEM AS WELL. NOT JUST THE PEOPLE WHO STEPPING DOWN, BUT ALSO THE CURRENT MEMBERS. ALL OF YOU HAVE BEEN SO GREAT OVER THE PAST COUPLE OF YEARS.

>> PAT: JUST ONE LAST THING ABOUT LISA I WANTED YOU TO KNOW. -- I'M PAT BY THE WAY.

LISA HAS BEEN ACCEPTED AND WE TALKED A LITTLE BIT ABOUT IT LAST MONTH WHEN SHE WASN'T HERE. SHE'S BEEN ACCEPTED INTO A PEER MENTORING PROGRAM THROUGH GALLAUDET IN. SO I JUST REALLY WANTED TO PERSONALLY THANK YOU.

>> LISA: LET'S GET STARTED.

EVERYONE HAVE A SEAT.

WELCOME BACK, EVERYONE.

OKAY. WE ARE GOING TO GET STARTED.

SO I JUST WANTED TO AGAIN THANK DIANE FOR BRINGING THIS CAKE. AS WE MENTIONED BEFORE BREAK, ALAN, HE WOULD HAVE 41 THIS COMING TUESDAY.

I THINK MOST OF YOU KNOW LAST MONTH WE HAD THIS HORRIBLE, SHOCKING AND HEART BREAKING NEWS THAT ALAN HAD PASSED AWAY. HE WAS AT LAST MONTH'S MEETING. I THINK HE TALKED TO SEVERAL PEOPLE. I UNFORTUNATELY MISSED THE MEETING.

AND JUST DAYS LATER HE PASSED AWAY.

THE CAUSE OF DEATH IS STILL INCONCLUSIVE I BELIEVE. WHAT WE DO KNOW IS HE HAD VERY BAD HEADACHES, ONGOING AND APPARENTLY HE WEN HOME, WENT TO SLEEP AND PASSED AWAY IN HIS SLEEP.

WE WANTED TO SPEND A FEW MINUTES TODAY TO SHARE OUR THOUGHTS IF ANYONE WANTS O SHARE ANYTHING IN REMEMBERING ALAN.

HE JOINED GROUP, I THINK ABOUT TWO YEARS AGO. I WISH I HAD GOTTEN TO KNOW HIM BETTER IN THAT TIME. WHAT I DO KNOW IS THAT HE REALLY MADE AN IMPRESSION. HE JOINED THE GROUP AND HE CAME TO ALMOST EVERY SINGLE MEETING AFTER THAT. EVERY EVENT. HE ALWAYS RAISED HIS HAND AND ASKED QUESTIONS. THIS ACTUALLY CAME UP AT

HIS MEMORIAL SERVICE, YOU START TALKING TO ALAN AND SUDDENLY YOU ARE TALKING ABOUT SOMETHING COMPLETELY DIFFERENT THAN WHAT THE TOPIC HAD STARTED OUT AS.

I KNOW THAT FOR ME, SOMETIMES I WOULD HAVE NO IDEA WHAT HE WAS TALKING ABOUT. AND IT HAD NOTHING TO DO WITH MY HEARING LOSS.

BUT I THINK THAT WU SOMETHING THAT WAS REALLY ENDEARING ABABOUT HIM. HE JUST HAD THIS VERY UNIQUE MIND.

THAT'S ONE THING THAT I REALLY LIKED ABOUT HIM.

THE OTHER THING I NOTICED RIGHT OFF THE BAT IS HE WAS ALWAYS, ALWAYS SO WILLING TO HELP. I THINK FROM THE VERY FIRST MEETING. YOU DIDN'T EVEN HAVE TO ASK HIM. HE WOULD START HELPING AFTER MEETING AT EVENTS, ALWAYS THERE LENING A HAND. I JUST -- LENDING.

I JUST WISH I WOULD HAVE TOLD HIM HOW MUCH I APPRECIATED THAT. I REALLY DID APPRECIATE IT.

A GROUP OF US WENT TO HIS MEMORIAL SERVICE. IT WAS A NICE SERVICE. WE HAD A LITTLE TROUBLE HEARING. BUT I LEARNED A LOT ABOUT ALAN.

THEY STARTED OFF THE SERVICE WITH A SLIDE SHOW. AND ONE THING I THOUGHT THAT WAS KIND OF, BROUGHTED A SMILE TO MY FACE, THEY HAD PICTURES OF ALAN WHEN HE WAS A BABY UP TO THE PRESENT DAY. AND HE LOOKED EXACTLY THE SAME. HIS WHOLE ENTIRE LIFE. I MEAN, I THINK THAT'S ONE OF THE THINGS THAT MADE HIM SO LIKABLE IS HE HAD THIS -- LIKE A BABY FACE.

SO IT WAS LIKE THIS LITTLE MINIATURE ALAN -- [LAUGHTER]

THE OTHER THING IS THAT I LEARNED THAT HE WAS INTO SO MANY DIFFERENT THINGS. THE SENSE I GOT IS THAT HE WAS, HE REALLY ENJOYED LIFE. HE WAS INTO PHOTOGRAPHY. HIKING. HE WAS LEARNING SPANISH. HE HAD A VERY STRONG FAITH. HE WAS GOING TO BIBLE STUDY CLASSES EVERY WEEK, I THINK WITH HIS MOTHER.

HE HAD A REALLY STRONG RELATIONSHIP WITH HIS FAMILY. HIS BROTHER-IN-LAW ACTUALLY WAS HIS FRIEND FROM SECOND GRADE. WHO ENDED UP MARRYING HIS SISTER. SO HE HAD THESE REALLY STRONG TIES.

>> MARCIA: WHAT IMPRESSED ME AFTER THE SERVICE IS THAT HIS MOTHER SPOKE. AND THAT REALLY GOT TO ME. THE RELATIONSHIP THAT THEY HAD, WHOLE FAMILY WAS A BEAUTIFUL THING. (BECOMING EMOTIONAL) AND HIS FRIENDS FROM SCHOOL EVEN SPOKE BESIDES HIS BROTHER-IN-LAW.

AND HE WAS A VERY CARING PERSON.

>> LISA: YEAH, HIS MOTHER SAID THAT HE ALWAYS CHECKED UP ON HER. THEY ALWAYS ENDED THE NIGHT BY TELLING EACH OTHER THEY LOVED EACH OTHER. AND AGAIN, HE HAD SEVERAL FRIENDS COME UP AND SPEAK. IT SEEMED LIKE ALL OF THEM HAS KNOWN HIM SINCE HIGH SCHOOL. HE, I THINK WHAT CAME THROUGH IS HE IS JUST A REAL CARING PERSON. HE HAD SOME REALLY GREAT FRIENDS. AND HE'S GOING TO BE VERY, VERY, SORELY MISSED.

>> DIANE: I'M DIANE. I HOPE IT IS OKAY IF I SIT HERE. I MADE SOME NOTES THAT I CAN'T READ IF I'M STANDING UP THERE.

GEORGIA AND I KNEW ALAN THROUGH HIS FACEBOOK PAGE. AND PAST COUPLE OF WEEKS I HAVE BEEN GOING BACK THROUGH THAT JUST READING OVER THE, THERE WAS JUST SO MANY TRIBUTES FROM HIS FRIENDS, PEOPLE WHO HAVE KNOWN HIM LIKE LISA SAID SINCE CHILDHOOD.

AND THERE WERE ALSO QUITE A FEW PICTURES OF ALAN WITH HIS NEPHEW, WHO I CAN'T REMEMBER THE BABY'S NAME. BUT HE JUST HAD HIS FIRST BIRTHDAY ON SEPTEMBER

19. SO ALAN DIED A FEW WEEKS BEFORE THE BABY'S FIRST BIRTHDAY.

AND THERE WAS JUST ONE VERY SWEET PICTURE OF ALAN'S NEPHEW AND THE CAPTION SAID "WE STILL HAVE A REASON TO LAUGH."

AND I STARTED THINKING WHAT KIND OF LEGACY DOES ALAN HAVE TO PASS ON TO HIS NEPHEW AND TO THE REST OF US?

JUST BASED ON SOME OF THE THINGS HIS FRIENDS HAVE SAID ON HIS PAGE, I JUST WANT TO SHARE A FEW THOUGHTS THAT I HAD.

ONE THING WAS KIND OF EXPLORE THE WORLD AROUND YOU AND BE CURIOUS ABOUT IT. BECAUSE HE HAD, LIKE LISA SAID, SO MANY DIFFERENT INTERESTS.

SO IT WAS TRAFFIC TIME GOING FROM THE WEST SIDE ALL THE WAY TO ALTADENA. GOT TO SPEND QUITE A BIT OF TIME WITH HIM. [GIGGLES].

AND ALL I REMEMBER -- IF YOU THINK YOU WERE GOING TO LEARN MORE ABOUT ALAN SPENDING MORE TIME WITH HIM, YOU WEREN'T. BECAUSE IT IS ALL QUESTIONS. ONE AFTER ANOTHER. AND QUESTIONS THAT LED DEEPER AND DEEPER INTO SUBJECTS I DON'T REMEMBER NOW WHAT WE TALKED ABOUT. BUT I HAD BRAIN DRAIN BY THE TIME I GOT HOME. [LAUGHTER]

THERE ARE NO FREE RIDES.

I ALSO KNOW THAT WE DON'T SMILE AS MUCH BECAUSE WE'RE SO BUSY AND INTENT ON TRYING TO HEAR, WE FORGET THAT WE CAN DO A LOT OF SMILING. AND HE DID THAT. AND SO I WANT TO TAKE AWAY THAT I WANT TO SMILE MORE. AND YOU KNOW, -- LIKE AT ANNE? JUST MAKING A WORLD OF A DIFFERENCE.

I WANT TO CARRY THIS SMILE THING WITH ME AND BE REMINDED OF ALAN. EVERYONE UNDERSTANDS IT IS UNIVERSAL.

>> LISA: ALICIA IS GOING TO READ SOMETHING. I'M GOING TO PUT IT UP HERE SO WE CAN FOLLOW ALONG.

>> ALICIA: I WENT ONLINE -- IS IT ON?

OKAY?

I WENT ONLINE AND I FOUND THIS -- --

>> DIANE: BIGGER MICROPHONE?

>> ALICIA: I FOUND THIS POEM OR SAYING BY AN UNKNOWN AUTHOR. IT OCCURS TO ME IT IS EXACTLY WHAT WE'RE ALL TALKING ABOUT.

IT'S NOT WORKING.

AND IT SHOCKED ME THAT THERE'S A LOT OF DIFFERENT NEEDS OUT THERE NOT JUST ONE -- NOT ONE KIND OF ASSISTIVE LISTENING DEVICE WILL HELP EVERYBODY.

SO I'D LIKE TO LOOK AT THAT.

THEN I THINK WHAT I MIGHT DO TO BRING TO THE STEERING COMMITTEE ARE ANYTHING THAT, ANY ARTICLES THAT I READ IN THE NATIONAL MAGAZINE. THE LATEST MAGAZINE THAT CAME OUT I READ THE PRESIDENT'S MESSAGE. [APPLAUSE]

- >> WENDI: DO YOU HAVE A HEARING LOSS?
- >> RAYLENE: A SMALL ONE.
- >> LISA: A MILD HEARING LOSS.
- >> RAYLENE: YES. I HAVE A SMALL HEARING LOSS. I TRIED USING THE IN-THE-EAR ONE, BUT I FELT IT WAS PLUGGING UP MY EARS SO I COULDN'T HEAR. SO THEN THE HEARING AIDS WERE NOT HELPING BECAUSE OF THAT PLUGGED-UP FEELING.

SO NOW I HAVE THE KIND, THE BEHIND-THE-EAR. I CAME HERE TODAY TO FIND OUT HOW THE T-COIL SOUNDS. BUT I DID NOT HEAR THE SOUND THAT MY DISTRIBUTOR THAT SELL ME MY HEARING AIDS, HE SAID I WOULD HEAR. - >> HI, I'M STEVEN GALLAY. OUR GOOD FRIEND LISA GOT ME HERE.

I HAVE BEEN LOSING MY HEARING. I DON'T HAVE A HEARING AID YET. BUT I'M GOING TO THE V.A. AND I'M NOT VERY HAPPY THERE. BUT, I'M GLAD I'M HERE. I'M LEARNING MORE ABOUT THINGS. AND THANK YOU.

>> LISA: THANK YOU.

[APPLAUSE]

>> I'M LIZ LEESON: I CAME LAST TIME WHEN LISA AND KEN WERE AWAY.

I LIVE IN WEST L.A. AND I HAVE ALSO GONE TO THE SANTA MONICA MEETING. I HAVE A MILD CONGENITAL HEARING LOSS. EVERYONE IN MY MOTHER'S FAMILY HAS SOME KIND OF HEARING LOSS. I HAVE A LITTLE BROTHER WHO STARTED LOSING HIS HEARING IN ELEMENTARY SCHOOL AND PRETTY MUCH NOT HEARING ANYTHING NOW.

MY OTHER SIBLINGS HAVE SOME LOSS. I'VE MET SOME OF MY COUSINS WITHIN THE LAST FEW MONTHS. SOME OF THE OUT-OF-STATE COUSINS ON MY MOTHER'S SIDE THAT I DIDN'T KNOW VERY WELL. MOTHER'S SIDE. AND DISCOVERED A LOT OF THEM HAVE GRANDMA'S HEARING LOSS TOO.

I'VE HAD HEARING AIDS FOR A COUPLE OF YEARS. AND IT WASN'T UNTIL I CAME TO THE SANTA MONICA MEETING THAT I EVEN KNEW THERE WAS SUCH A THING AS A TELECOIL. AND ONCE I LEARNED ABOUT IT, I CALLED UP MY AUDIOLOGIST AND DEMANDED THEY TURN IT ON. WHICH HAS BEEN REALLY HELPFUL.

AND SO, I'M LOOKING TO GET MORE INVOLVED AS TIME GOES ON. ALTHOUGH I'M STILL WORKING MANY HOURS AND THIS IS A REALLY BUSY SEASON. BUT I LOVE THIS MEETING. SO MUCH EXCHANGE OF IDEAS.

PAUL STUESSY IS HER HUSBAND. HE WORKS FOR HAMILTON RELAY. HE WAS THE SOUTHERN CALIFORNIA COORDINATOR. AND HE GOT TRANSFERRED. STILL WORKING FOR HAMILTON, BUT HE'S AN EAST COAST PERSON NOW.

SO THEY MOVED TO VIRGINIA. SO G.L.A.D. HAS HIRED A NEW HEARING LOSS SPECIALIST. SHE WAS GOING TO BE HERE TODAY AND INTRODUCE HERSELF AND SPEAK. AND SHE HAD A FLAT TIRE. SO HOPEFULLY WE'LL MEET HER AT ANOTHER UPCOMING MEETING.

I ALSO JUST MET THE WOMAN WHO IS TAKING PAUL STUESSY'S PLACE AT HAMILTON, AT THE GALLAUDET PEER MENTORING PROGRAM. SO SHE IS EXCITED TO COME AND INTRODUCE HERSELF. THAT'S WHY WE ORIGINALLY -- I THOUGHT WE WERE GOING TO BE GOING OVER TIME. BUT UNFORTUNATELY SHE HAD TO CANCEL.

- >> LISA: MY COCHLEAR IMPLANT ALSO DIED A COUPLE OF MONTHS AGO. AND I ALSO GO TO HOUSE. AND I GOT A LOANER. SO I HOPE I DON'T HAVE THE ONLY LOANER.
  - >> PAT: I DIDN'T KNOW THEY COULD DIE.
  - >> LISA: MINE IS FEW YEARS OLD. I KNOW YOU JUST GOT YOURS RECENTLY, RIGHT?
  - >> PAT: WELL, MINE IS JUST A YEAR OLD.
  - >> LISA: THAT SHOULDN'T HAVE DIED ALREADY.
  - >> PAT: SO --
  - >> GARY: DIED ON ME TWICE IN ONE YEAR.
  - >> LISA: REALLY?
  - >> FROM HOUSE?
  - >> GRACE: GO TO KAISER. JOIN KAISER.
  - >> PAT: THAT SOUNDS LIKE IT'S A POSSIBILITY.
  - >> LISA: I HOPE THEY GET IT STRAIGHTENED OUT.
  - >> PAT: THANK YOU. I HOPE SO TOO.
  - >> ALICIA: YELL AT PEOPLE.

ANYWAY, YEAH. I -- YOU HAVE TO REALLY PUSH. YELL AT PEOPLE. AND DEMAND THEY DO WHAT IS NECESSARY. BECAUSE THERE'S NO WAY A COCHLEAR IMPLANT SHOULD DIE WITHIN A YEAR. SAME GOES FOR THE OTHER PEOPLE HERE.

I'VE HAD MINE FOR QUITE A FEW YEARS AND BOTH OF THEM AND THEY WORK VERY WELL.

IT JUST UNCONSCIONABLE. NOT LIKE YOU HAVE A CHOICE AND WANDER AROUND AND NOT HEAR ANYTHING. SO MAKE A LOT OF NOISE THAT SEEMS TO WORK. I HATE TO BE PUSHY, BUT THAT'S WHAT YOU NEED TO BE.

KAT: I'M KAT, AND I'M NERVOUS NOW THAT I'M TRYING TO GET AN APPOINTMENT WITH KAT -- [LAUGHTER]

I MEAN -- APPOINTMENT -- I'M TRYING TO MAKE AN APPOINTMENT WITH HOUSE FOR A

COCHLEAR IMPLANT EVALUATION AFTER TALKING TO SUZANNE WHO SPOKE AT OUR MEETING A MONTH AGO, I WAS SO INTRIGUED BY ALL OF THE POSSIBILITIES. BUT I HAVE BEEN TRYING FOR THREE WEEKS TO GET AN APPOINTMENT. SUZANNE IS ALL FOR IT. SHE KEEPS TELLING THEM TO MAKE AN APPOINTMENT TO SEE ME. AND HAD PERSON HAS TO GET THIS, I HAVE TO SEND THIS. YOU KNOW, MY PAPERS. I'M SCANNING STUFF, SENDING IT TO THEM. WAIT, WAIT, FOLLOW UP. WAIT. FOLLOW UP.

ANYWAY, SO I'M ALREADY A LITTLE FRUSTRATED. AND NOW -- ANYWAY. WE'LL SEE.

>> LISA: THAT'S STRANGE.

>> I'M STEPHANIE. I CALLED HOUSE TOO BECAUSE I WANTED TO TRY TO CHECK UP, I HAD THE SAME TROUBLE THAT KAT HAD. SO A LITTLE FRUSTRATING TO WAIT AND WAIT.

I HAVE HEARING AID AND I'M DOING A TRIAL RIGHT NOW WITH MY AUDIOLOGIST TO TRY TO FIND THE BEST ONES FOR ME.

BUT I'M LOOKING INTO COCHLEAR IMPLANTS TOO. SO I WANT TO START TO SEE AND HEAR AND UNDERSTAND BETTER, EVEN WITH HEARING AIDS AND STILL NOT UNDERSTANDING AS WELL.

BUT THE NEW ONES I'M TRYING TODAY, I'M DOING A LOT BETTER TODAY. USUALLY I STRUGGLE HERE. SO I KEEP COMING SO THERE MUST BE A REASON.

- >> DIANE: I'M DIANE. AND I DO BELONG TO KAISER. BUT I'M THINKING FROM WHAT I'M HEARING ABOUT HOUSE IT SOUNDS VERY MUCH LIKE DEALING WITH THE STATE DEPARTMENT OF REHABILITATION. I'VE BEEN WAITING TWO YEARS TO GET EQUIPMENT FROM THEM.
  - >> MITZI: I'M MITZI.
  - >> JOHN.
  - >> I'M ANNE. I'M A FRIEND OF TOM'S.
- >> I'M TOM. AND I KIND OF -- I'M KIND OF A LONER TOO. I'VE BEEN SITTING HERE FOR TWO HOURS AND HAVEN'T SAID ANYTHING. I DO FEEL BETTER WHEN I COME TO THESE MEETINGS.
  - >> GRACE: GRACE AGAIN.
  - >> LISA: I THINK WE HAVE IT.

[LAUGHTER]

ALL RIGHT.

THANK YOU, EVERYONE.

- >> PUAY: LISA, CAN YOU TELL US HOW YOU ARE DOING WITH THE COCHLEAR IMPLANT? ARE YOU DOING A LOT BETTER? BECAUSE I AM CONSIDERING, AND I WANT TO KNOW HOW YOU ARE DOING.
- >> LISA: I STILL HAVE THE SAME PROBLEM. I DON'T THINK A LOT OF PEOPLE KNOW. I HAD A LOT OF PROBLEMS WITH MY COCHLEAR IMPLANT WITH THE SOUND QUALITY, WHERE EVERYTHING SOUNDED LIKE A MARTIAN. WHICH IS NORMAL AT FIRST. BUT I THINK OVER TIME IT IS SUPPOSED TO START SOUNDING NORMAL.

AND IT WAS JUST HARD TO UNDERSTAND PEOPLE, BECAUSE IT WAS SOUNDING LIKE PEOPLE WERE UNDER WATER OR TALKING FROM A DEEP WELL.

AND AFTER FOUR YEARS OR SO, I STILL COULDN'T TELL THE DIFFERENCE BETWEEN MALE OR FEMALE. THE SOUND QUALITY WAS SO POOR. SO I FINALLY GOT RE-IMPLANTED. THE NEW IMPLANT, THE SAME THING KIND OF HAPPENS. WHICH WAS DEPRESSING. BUT I REALIZED THERE WAS SOMETHING GOING ON WITH MY BRAIN THAT WANTS TO HEAR ALIENS.

SO THAT'S FINE.

[LAUGHTER]

SO, ANYWAY, WHAT HAPPENED WAS I THINK THIS ONE IS SLOWLY BEEN IMPROVING. AND I -- MY COMPREHENSION HAS GOTTEN SO MUCH BETTER THAT I DON'T NOTE THE SOUND QUALITY SO MUCH ANYMORE. I'M JUST THANKFUL TO BE ABLE TO UNDERSTAND SPEECH A LOT BETTER.

SO IT IS WORKING OUT WELL. I'M ACTUALLY VERY THANKFUL FOR MY IMPLANT NOW. I HEAVILY DEPEND ON IT.

- >> GRACE: SPEECH SOUNDS TERRIBLE -- MUSIC SOUNDS AWFUL. SPEECH SOUNDS TERRIBLE. ALL I ASK FOR IS SPEECH COMPREHENSION. BUT IT SOUNDS LIKE I'M TALKING TO ALIENS. AND I DON'T KNOW IF I CAN TELL THE DIFFERENCE BETWEEN MEN AND WOMEN. BUT LOOK, -- (DEMONSTRATING). . .
- >> LISA: ALL RIGHT. WE ARE OUT OF TIME -- ONE MORE COMMENT? THEN WE ARE GOING TO WRAP THINGS UP.

>> THIS IS NOT -- I'M MAKING A COMMENT THAT IS NOT ABOUT HEARING. SEVERAL OF YOU MENTIONED THAT YOU ARE KAISER MEMBERS. IF YOU AREN'T AWARE OF IT, THEY ARE DOING DRIVE-THROUGH FLU CLINICS. IF YOU KNEW THAT THERE WAS ONE LAST YEAR SOMEWHERE, IT'S PROBABLY AT THE SAME PLACE THIS YEAR.

I DIDN'T GET A NOTICE. BUT FOUND OUT THERE'S ONE IN WEST L.A. THERE'S ONE IN ANTELOPE VALLEY. SO IF THERE WAS ONE IN THIS AREA WHERE YOU FOLKS LIVE, YOU MIGHT WANT TO CHECK IT OUT. DRIVE BY THERE. BECAUSE YOU DRIVE IN, STICK YOUR CARD OUT THE WINDOW. THEY FILL OUT A FORM. STICK A NEEDLE IN YOUR ARM AND YOU'RE ON YOUR WAY.

>> I JUST WANT TO SAY, I'M RICHARD. AND I WANT TO THANK YOU ALL FOR ALLOWING ME TO ATTEND YOUR MEETING. IT IS A VERY SPECIAL GROUP. I JUST WANT TO SAY. THANK YOU.

- >> JEANNE: IS IT YOUR COCHLEAR IMPLANT OR YOUR PROCESSOR?
- >> LISA: MY IMPLANT. THEY CHECKED EVERYTHING?
- >> THEN YOU HAD TO GO IN FOR SURGERY AND HAVE THE IMPLANT TAKEN OUT?
- >> YES. AND THIS ONE IS BETTER. THE SOUND QUALITY IS BETTER. I'VE DEFINITELY NOTICED IMPROVEMENT NOW. IT'S BEEN TWO YEARS. I THINK IT IS HAPPENING VERY SLOWLY. BUT DEFINITELY AM --
  - >> COCHLEAR AMERICA?
  - >> LISA: THEY GAVE ME THE FREEDOM. THEY WENT BACKWARDS.

BUT MY PROCESSOR IS A NUCLEUS 5. AND I'M ACTUALLY TRYING TO GET UPGRADE NOW TO THE 6. BUT MY -- LONG STORY. I WAS DENIED BY INSURANCE. SO IT IS A PROCESS.

I WANTED TO REMIND PEOPLE AGAIN WE ARE TALKING ABOUT TELECOILS. YOU SHOULD CHECK THIS OUT HERE AT THE HEAR CENTER. IT'S FREE. YOU CAN GET YOUR HEARING AIDS AND HEARING TESTING. YOUR TELECOIL CHECKED.
